To all whom these presents shall come **Richard Davis** of Lewknor in the County of Oxford Gentleman **John Davis** of Bloxham in the said County of Oxford Gentleman and **Edward Barton** of Headington in the said County of Oxford Gentleman Commissioners appointed in and by a certain Act of Parliament made and passed in the forty first year of the reign of His present Majesty King George the Third intituled "An Act for dividing allotting and laying in severalty the open and common Fields common Pastures common Meadows Commons and waste grounds within the Parish of Headington in the County of Oxford" **And also** Letitia Finch of Headington aforesaid Widow Mary Jones of the City of Oxford Spinster the Reverend Martin Joseph Routh Doctor in Divinity President of the College of Saint Mary Magdalen in the University of Oxford and the Scholars of the said College and the said Letitia Finch Widow and Executrix of the last Will and Testament of Richard Finch the Elder late of Headington aforesaid Esquire deceased their Lessee George White of Newington in the County of Oxford Esquire surviving Trustee in the Settlement made upon the marriage of the said Richard Finch with the said Letitia his wife the Reverend John Cook Doctor in Divinity President of Corpus Christi College in the said University of Oxford and the Scholars of the same and Henry Mayne Whorwood of Headington aforesaid their Lessee **And also** the said Henry Mayne Whorwood **Send Greeting and first know ye** that the said Commissioners having in pursuance of the said Act of Parliament and according to the direction thereof given due notice of their first meeting have put in execution the powers vested in them and having each of them before them executed any other such power and powers (except the power thereby given of administering the Oath to each other) taken and subscribed the Oath of the said Act directed to be taken by Commissioners and which Oaths are hereunto annexed to the intent the same may be inrolled with these presents And having also given Notice of all other their meetings for putting in execution the powers of the said Act (meetings by Adjournment only excepted) and having viewed the "Common fields and all other the premises of the said Act intended to be divided allotted and layed in severally" And also of the homesteads, home closes and other common inclosures within the said Parish and considered and made a distinct valuation thereby and of all Tithes Moduses or Compositions of what nature kind soever issuing and arising thereto or due and payable for the same and having caused a true and perfect survey admeasurement and plan of the said open and common Fields common Pastures common Meadows Commons and waste ground of the said Act intended and directed to be divided allotted and layed in severally **And also** of all the homesteads, home closes and other antient Inclosures within the said Parish by William Rutt and Edward Kelsey of Oxford Surveyors and which survey admeasurement and plan having been by them reduced into writing and the contents of the whole premises and the several parcels of Land and number of acres and decimal parts of acres in statute measure belonging to each proprietor set forth and ascertained And the said Survey admeasurement and plan laid before them the said Commissioners at their several meetings held in pursuance of the said Act And they the said William Rutt and Edward Kelsey having previously taken and subscribed the Oaths directed by the said Act to be taken by Surveyors which Oaths are also hereunto annexed to the intent the same may be inrolled as aforesaid And the said Commissioners having perused and well considered such survey admeasurement and plan and also heard and duly informed themselves of the rights and claims of all parties inside therein and settled and determined the same and all differences and disputes whatsoever as well as all other matters and things relating to the said division and allotment by the said Act committed unto them **They the said Commissioners** have set out and appointed And of these presents do in the first place set out and appoint the several public and private Roads and Ways in over and upon the Lands and grants of the said Act intended to be denoted and allotted in manner hereinafter mentioned (that is to say):

*[I: London Road]*

**One Public Carriage Road and Driftway** of the breadth of sixty feet numbered **I** in the plan hereunto annexed being the new Turnpike Road leading from London to the City of Oxford which is to be continued in its present track and direction

*[II: Old High Street]*

**Also One Other Public Carriage Road and Driftway** of the breadth of forty feet numbered **II** branching out of the said new Turnpike Road and beginning at a certain place there called High Cross Bush and extending in a North Eastward direction to the village of Headington aforesaid

*[III Windmill Road & The Slade]*

**Also one other public Carriage Road and Driftway** of the like breadth of forty feet numbered **III** likewise branching out of the said new Turnpike Road at High Cross Bush aforesaid and extending in a Southward direction across Wood way furlong into the antient Turnpike Road leading from London to the City of Oxford and continuing over a certain place called "Harry Bears Bottom" and extending from thence along the Slade near to a Farm house belonging to the President and Scholars of Magdalen College and their Lessee John Townsend being part of the public Road leading from Headington aforesaid towards Garsington

*[IV Bayswater Road]*

**Also one other public Carriage Road and Driftway** of the like breadth of forty feet numbered **IV** likewise branching out of the said new Turnpike Road near to the spot where the windmill formerly stood and extending along the Hollow Way between the furlongs called Inott and Sandhill into the Parish of Stanton St John in the said County of Oxford at a certain place called Bayswater being part of the public Road from Oxford to Stanton St John and the Otmoor towns

*[V Toot Hill Butts to Quarry Road]*

**Also one other public Carriage Road and Driftway** of the like breadth of forty feet numbered **V** likewise branching out of the said Turnpike Road at a furlong called Toot-hill Butts Furlong and extending in a Southward direction from the same Turnpike Road to Headington Quarry and from thence in a Westward direction through the said Quarry whence taking a South West direction on the South East corner of the fourth Allotment of the President and Scholars of Magdalen College and their Lessee Theophilus Wharton it leads into a certain common called Quarry Copse near the bottom of Shotover Hill being part of the public Road leading from Stanton St John to Cowley

*[VI Barton Road]*

**Also one other public Carriage Road and Driftway** of the like breadth of forty feet numbered **VI** likewise branching out of the said new Turnpike Road in a North Eastward direction and leading from thence in the present track along a certain Meer called Blackthorn Meer to the village of Barton in the County of Oxford the same being set out as the public Road leading from the said new Turnpike Road to Barton aforesaid

*[VII Old Road]*

**Also one other public Carriage Road and Driftway** of the like breadth of forty feet numbered **VII** Also one other public Carriage Road and Driftway beginning at the East End of

a certain Lane called Cheyney Lane and extending in the track of the said antient Turnpike Road crossing the said Carriage Road and Driftway numbered **III** near to a house called Titup Hall and continuing from thence into the common called Quarry Coppice being part of the public Road leading from the city of Oxford to Cuddesdon in the said county of Oxford

*[VIII Osler Road]*

**Also one other public Carriage Road and Driftway** of the like breadth of forty feet numbered **VIII** likewise branching out of the said new Turnpike Road near to a certain public House called the Britannia and extending from thence in a North Eastward direction across a certain Furlong called Young Stile Furlong to the corner of a certain Messuage or Tenement in Headington aforesaid now in the occupation of John Parsons Esquire being part of the public Road leading from the City of Oxford aforesaid to other part of the Village of Headington aforesaid

*[IX Marston Road]*

**Also one other public Carriage Road and Driftway** of the like breadth of forty feet numbered **IX** beginning at the North West end of a certain Lane called Marston Lane and leading from thence in a North Eastward direction over a small piece of Common called Grate into other part of Marston Lane aforesaid being part of the public Road leading from the City of Oxford aforesaid to Marston in the said County of Oxford

*[X Barton Lane]*

**Also one other public Carriage Road and Driftway** of the like breadth of forty feet numbered **X** beginning near a certain public House in Headington aforesaid called the Black Boy and leading from Headington aforesaid in an Eastward direction to the Hamlet of Barton aforesaid being the public Road from Headington aforesaid to Barton village

*[XI Dunstan Road]*

**Also one other public Carriage Road and Driftway** of the like breadth of forty feet numbered **XI** beginning at the end of an inclosed Lane on the North West End of the village of Headington and extending first in a Northward and afterwards in a North Westward direction across a Common called Hen Grove into another inclosed Lane leading towards Marston being part of the public Road leading from the village of Headington aforesaid to Marston aforesaid

*[XII Gipsy Lane]*

**Also one Public Bridle Road and private Carriage Way** of the breadth of thirty feet numbered **XII** branching out of the said Road numbered **I** between the Allotments numbered **XVIII** and **XIX** and extending from thence in a South Westward direction and leading into the Road numbered **VII** being intended as a bridle way for the public and a Carriage Way for the several Owners and Occupiers of land within the said Parish of Headington

*[XIII Lane from London Road to Sandhills]*

**Also one other public Bridle Road** of the breadth of fourteen feet numbered **XIII** branching out of the Turnpike Road numbered **I** to certain cottages and gardens called Sandhill and extending in an eastward direction through

Taggs Gate in the Parish of Forest-hill being part of the public Bridle Road from Oxford to Forest Hill

[XIV Barton Village Road]

**Also one private Carriage Road and Driftway** of the breadth of forty feet numbered **XIV** leading in a Northward, North Eastward and South Eastward direction from Barton near the cottage of John Smith to the Wick Farm in Headington aforesaid which said private Road and Driftway is hereby set out to and for the use of owners and occupiers of the said Wick Farm for the time being

[XV Lane off west side of Windmill Road, near present Nuffield Orthopaedic Centre]

**Also one private Carriage Road and Driftway** of the breadth of twenty feet numbered **XV** branching out of the public Road numbered **III** near the allotment numbered 24 and leading to the allotment numbered 22 which said last mentioned Road is hereby set out for the use of the owners and occupiers of the said last mentioned allotment for the time being

[XVI Footpath from Stoke Place to Elsfield]

**Also one other private Carriage Road and Driftway** of the breadth of twenty feet numbered **XVI** leading in a North Eastward direction from the lane between certain old enclosures now or late belonging to Richard Finch Which said last-mentioned Road is hereby set out for the use of Owners and Occupiers of the Allotments numbered 78, 79 and 80 for the time being

[XVII Track running north from Barton Lane]

**Also one other private Carriage Road and Driftway** of the like breadth of twenty feet [presumably numbered **XVII**] branching out of the Road numbered **X** across a certain close called Mead Close to the Allotment numbered 89 Which said last mentioned Road is hereby set out for the use of the Owners and Occupiers of the said last mentioned Allotments for the time being

[XVIII Cuckoo Lane (from Pullens Lane to Old High Street)]

**Also one public Footpath** of the breadth of six feet numbered **XVIII** beginning at a certain Tree called Joe Pullen's Tree and extending from thence in an Eastward direction across the Allotment numbered 64 by the public Road numbered **VIII** the Allotment numbered 63 and the Allotment numbered 62 into the Road numbered **II** near the village of Headington aforesaid the same being set out as the Public Foot Road from Headington to Oxford

[XIX Footpath: west end of The Croft]

**Also one other public Foot path** of the breadth of four feet numbered **XIX** branching out of the Public Road numbered **VIII** near the Allotment numbered 63 and leading from thence near the Public House called the Rose and Crown into the village of Headington

[XX Funeral path from North Place to Holy Trinity Church, Headington Quarry]

**Also one other public Foot path** of the like breadth of six feet numbered **XX** beginning near the blacksmith's shop of William Lawrance in Headington aforesaid and extending from thence in a Southward direction through and over the Allotment numbered 58 into the Road numbered **I** and branching from thence in a South Eastward direction over the several Allotments numbered 29, 36, 37, 38, and 40, to Headington Quarry, the same being set out as the public Foot Road leading from the Village of Headington aforesaid to Headington Quarry aforesaid

[XXI Footpath from Barton to Beckley]

**Also one other public Foot path** of the like breadth of four feet numbered **XXI** beginning at an old inclosure in Barton aforesaid belonging to Henry Godfrey and extending from thence in a North Eastward direction over the Allotment numbered 99 into a meadow called Wick Meadow and leading from thence towards the village of Beckley

[XXII Footpath opposite Barton Road leading to Quarry]

**Also one other public Foot path** of six feet numbered **XXII** branching out of the said Road numbered **I** at the junction of the same with the Road numbered **VI** and extending over Allotments numbered 39 and 40 the same being set out as the public Foot Road leading from Barton aforesaid to Headington Quarry

[XXIII Footpath from Barton to Stanton St John]

**And also one other public Foot path** of the breadth of four feet numbered **XXIII** branching out of the Road numbered **VI** above Barton and extending in a South Eastward direction over the Allotment numbered 48 into the Road numbered **IV** being a public Foot path leading from the said last mentioned Road towards Stanton St John

**All which** said public and private Roads and Ways hereinbefore particularly set out mentioned and described are all the public and private Roads and Ways the said Commissioners have requested to be set out and appointed for ever through or upon the lands and Grounds by the said Act directed to be divided allotted and which said private Roads and Ways so set out and appointed the said Commissioners do order and direct being made established repaired by and at the expense of the several Owners and Occupiers of the Lands and Estates in the Parish of Headington aforesaid for whose use respectively the same private Roads and Ways are set out And the said Commissioners do further order and direct that the Herbage growing and renewing upon the said public and private Roads and Ways in such places and where the said Roads are bounded on both sides by new allotments established taken by and belonging to the owners each of the allotments adjoining the same to the Centre thereof respectively And in such places where the said Roads are bounded on one side only by new Allotments the Herbage shall be taken of and belonging on to the owner of the Allotment adjoining the same or through which such Road passes

#### **Common Land: Plot No. 4**

4. **And** the said Commissioners in further pursuance of the said Act have set out and allotted And by these Presents do award one Plot of Land or Ground numbered 4 on the Plan hereunto annexed containing one acre situate in a certain part of the common called the Slade near to a Farm house belonging to the said President and Scholars of Saint Mary Magdalen College in the occupation of John Townesend bounded on the North by the Allotment numbered 5 On the East by the Old Inclosures belonging to the said President and Scholars of Saint Mary Magdalen College and their Lessee the said John Townesend on the South by other part of the said Common called the Slade and on the West by the Road numbered **III** which said allotment is hereby set out allotted and awarded with Stone, Sand and Gravel Pits to be used in Common by the Proprietors of Lots and Estates in the Parish of Headington aforesaid and their tenants as well as for their own necessary uses as for repairs of the Turnpike Roads or other public and private Roads in the said Parish

#### **Henry Mayne Whorwood: Plots No. 12, 1, and 65**

12 **And** the said Commissioners in further pursuance of the said Act have further set out and allotted And by these Presents do award unto the said **Henry Mayne Whorwood** as Lord of the Manor of Headington aforesaid **One Plot of Land or Ground** numbered 12 containing one acre and one rood situate in South Field bounded on the North by the Allotments numbered 14 and 13 and on the East South and West by the Allotment numbered 1 And which said Allotment numbered 12 is in the judgement of the said Commissioners a full recompence and satisfaction of and for all right of soil the said Henry Mayne Whorwood as Lord of the said Manor of Headington in or to the Soil of the said waste lands within the same Manor And the same Allotment numbered 12 they the said Commissioners have ascertained to be exonerated and discharged from the payment of Land Tax by virtue of the purchase thereof under the authority and in the manner directed by an Act passed in the thirty eighth year of his present Majesty's Reign for that purpose

**And** the said Commissioners in further pursuance of the said Act have set out and allotted and by these Presents do award unto and for the said Henry Mayne Whorwood for and in lieu of his rectorial Tithes (no land having been either claimed or ascertained as Glebe notwithstanding diligent inquiry has been made respecting the same) the **Two several Plots** of Land or Ground next hereinafter mentioned and described (that is to say)

1 **One Plot** of Land or Ground numbered 1 containing two hundred acres three roods and thirty three perches situate in the south field bounded on part of the north by the Freeboard of Mrs Smith in Saint Clement's Parish on parts of the East and other parts of the North and on part of the West by the Allotment numbered 15 on other part of the North by the Allotment numbered 14 on part of the East on part of the North and on other part of the West by the Allotment numbered 12 on other part of the West by the Allotment numbered 13 On other part of the north by the Road numbered **VII** on other parts of

the East and North by the Allotment numbered 11 on other part of the North by the Allotment numbered 10 on the South East and North East by the Allotment numbered 2 on part of the South and South West of Lands in the Parish of Cowley on remaining parts of the North the West and South by Bartholomew's Closes in the Parish of Cowley aforesaid and on remaining part of the South West by other lands in the said Parish of Cowley

65 And one other Plot of Land or Ground containing twenty acres and three roods situated in Brockholes Field bounded on the North East and South East by the Allotment numbered 64 on the South West by the Allotment numbered 66 and on the North West by the Road numbered **IX** and Marston Lane and which said Allotments numbered 1 and 65 they the said Commissioners have ascertained to be exonerated and discharged from the payment of Land Tax by virtue of the purchase thereof in manner aforesaid

#### **Vicar of Headington: Plots No. 2 and 6**

**And** the said Commissioners in further pursuance of the said Act have set out and allotted and to these Presents to award unto and for the **Reverend John Wills** Doctor of Divinity and his successors Vicars of the Vicarage of Headington aforesaid for and in lieu of Vicarial Tithes (except Mortuaries Easter offerings and Surplice Fees) **two several Plots** of Land or Ground next hereinafter mentioned and described (that is to say)

2 **One Plot** of Land or Ground numbered 2 containing 90 acres and fourteen perches situate at Inott and Town Furze bounded on part of the North by the Allotment numbered 9 on other part of the North and on part of the North West by the Allotment numbered 7 and the remaining part of the North by the Road numbered **VII** on part of the East by the Road numbered **III** on parts of the South, South East and North East by the Allotment numbered 3 on the other part of the South East remaining part of the East and remaining part of the South East and on the West by Lots in the said Parish of Cowley and on the South West and on the remaining part of the North West by the Allotment numbered 1

6 **One other Plot** of Land or Ground numbered 6 containing six acres one rood and three perches situate in Harry Bears Bottom bounded on the North by the Road numbered **VII** on the South East by an old inclosure belonging to the President and Scholars of Saint Mary Magdalen College and their Lessee the said John Townesend and on the South by the Allotment numbered 5 on the West by the Road numbered **III** Which said two several Plots of Land or Ground hereinbefore awarded for rectorial tithes and the said two last described Plots of Land or Ground allotted for vicarial tithes taken collectively are in the judgement of the said Commissioners and they do hereby adjudge the same to be (quantity quality and situation considered) equal in value to one fifth part of the arable Land and one ninth part of the meadow pasture or greensward Ground within the Parish of Headington that are subject to the payment of tithes after deducting the Allotments hereinbefore awarded for Roads and quarries pursuant to the directions of the said Act but no glebe Land having been

claimed or ascertained as aforesaid (Mortuaries Easter offerings and surplice Fees due to the said Vicar excepted)

### **The Poor: Plot No. 3**

- 3 **And** the said Commissioners in further pursuance of the said Act have set out and allotted and by these presents do award unto the Lord of the Manor of Headington and the Vicar Minister and Church Wardens of the said Parish of Headington for the time being as Trustees for the Poor Inhabitants of Headington aforesaid for the purposes mentioned in the said Act **One Plot** of Land and ground numbered 3 containing five acres situate in the

Peat Moor bounded on part of the South West and on the North West and the North by the Allotment numbered 2 on the East by the public Road numbered **III** and on the South East and remaining part of the South West by lands called Hundred Acres in the said Parish of Cowley Which said Plot of Land or Ground numbered 3 is in the judgement of the said Commissioners a full and ample equivalent and satisfaction for certain indulgencies usually had by the said poor Inhabitants in cutting taking and carrying away Furze and Fern and digging and carrying away Peat for their own use from certain parts of the said commons or waste grounds by the said Act intended to be divided and allotted

And the said Commissioners in further pursuance of the said Act have set out and allotted And by these presents do Award **All the residue** of the lands and grounds of the said Act intended to be divided and allotted unto and amongst the several owners and proprietors thereof in proportion to their lands rights of Common and other Rights Necessities and Property in and over the same in manner following (that is to say)

### **James Alley/Leverett: Plots No. 76 and 77**

- 76 **To and for James Alley** otherwise **Leverett** in lieu of his copyhold parcel or ley of meadow held under the Manor of Headington and certain right of common land thereto belonging **One Plot** of Land or Ground numbered 76 containing one acre two roods and twenty five perches situate in the Meadow bounded on the North West and part of the North East by an old inclosure belonging to Robert Spindler and the Allotment numbered 75 on the remaining part of the North East by the Allotment numbered 77 on the South East by the Allotment numbered 78 and on the South West by the old Inclosures belonging to the said James Alley

Allotment numbered 95 and on the North West by the allotment numbered 93.

- 51 And to and for Benjamin Beasley** in lieu of copyhold lands held under the Manor of Headington and certain rights of Common thereto belonging One Plot of land or Ground numbered 51 containing five acres three roods and thirty five perches situate in Barton field bounded on the North East and South East by the Allotment numbered 48 on the South West by the Allotments numbered 49 and 50 and on the North West by the Road numbered **VI**

#### **Elizabeth Bostall: Plot No. 14**
